

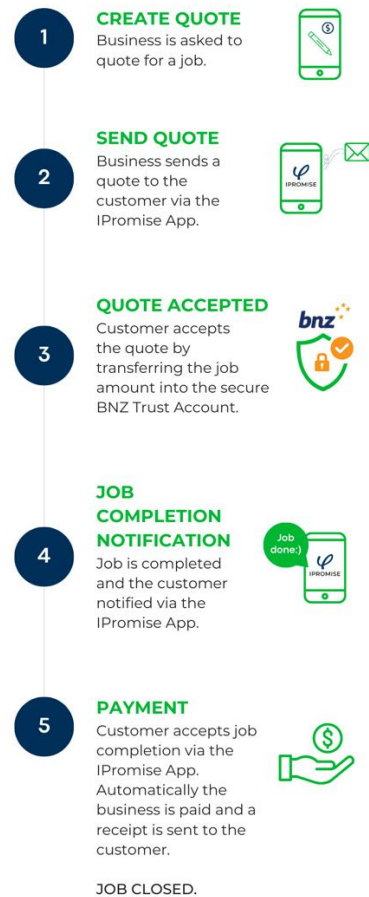
Features
